## **Manufacturer's Certification Statement**

To: All Viwinco Building Professional Customers and Homeowner Customers:

This letter is to verify that the Viwinco exterior window products as listed on the following pages are Eligible Building Envelope Components.

- **a)** Products shipped between January 1, 2015 and December 31, 2015, meet or exceed prescriptive criteria in all climate zones as established by the IECC for energy tax credit consideration for exterior window products.
- **b)** Products shipped as of the date indicated on the matrix on the following pages meet or exceed the energy performance criteria as set forth. All qualifying windows must meet ENERGY STAR; the window limit incentive is \$200.00.

This letter is provided as a verification in lieu of the appropriate labeling for those products ordered and received in the early stages of our manufacturing changes, prior to formal certification and formal labeling approval from the labs that review and certify Viwinco products.

The expanded time line of the product alterations made by Viwinco to meet the Energy Tax Criteria (initially to change glass packages in style offerings and then to switch nearly all products to the Intercept ULTRA spacer) not only illustrates our course of actions, but also indicates when ARRA criteria-compliant products were being shipped. Please note that as of April 17, 2009, ALL formal, National Fenestration Rating Council (NFRC) third party-approved certifications and labeling were in hand and in use.

Under penalties of perjury, I declare that I have examined this certification statement, and to the best of my knowledge and belief, the facts are true, correct, and complete.
